

General Terms and Conditions

Introduction

The Institute of Biotechnology of the CAS, v. v. i., ID No.: 866 52 036, located at Průmyslová 595, 252 50 Vestec (hereinafter referred to as "IBT" or "organizer"), organizes educational courses, seminars, and workshops (hereinafter referred to as "courses") in the field of quantitative PCR, digital PCR, miRNA, single cell analysis or spatial transcriptomics, through the Gene Core - Quantitative and Digital PCR service laboratory.

These General Terms and Conditions regulate the relationship between the organizer and the course participants and are binding on both parties.

Registration

Registration for the courses is done by sending a binding application for the course by the participant. Sending a binding application form can only be done by registering on the organiser's website <https://www.ibt.cas.cz/cs/servisni-pracoviste/gene-core/#courses>. After registration, the participant will receive an e-mail confirmation of registration. Participants will be registered in the order in which the applications are received until the course is full. Details regarding the content of the relevant course, course price, venue and timetable are available on the IBT website.

Price and payment conditions

The price of the course is in CZK without VAT. VAT will be added to the price of the course at the legal rate.

The price of the course always includes information materials for the course. Other items (e.g. coffee, refreshments, lunch, etc.) are included in the course price only if this is explicitly stated for the course on the IBT website.

The price of the course is payable on the date stated in the invoice that the participant will receive by e-mail. Participants who do not pay the course price by the required date will not be included in the course.

Cancellation of registration

If the IBT receives a cancellation of registration by a participant no later than 15 days before the start of the course, or 30 days before the start of a course longer than one day, the course fee will be refunded to the participant in full without undue delay. In the event of cancellation of registration by the participant received less than 15 days before the start of the course or 30 days before the start of a course longer than one day, the course fee paid will not be refunded. If the participant is unable to attend the course for any reason, he/she may assign his/her registration to another participant, whom he/she will arrange.

The IBT reserves the right to cancel a course in the event of insufficient capacity, illness of the lecturer or other serious reasons. In such a case, the IBT will refund the course fee in full or offer the participant to attend the course on an alternative date. The participant shall not be entitled to any refund or compensation for the cancelled course.

Intellectual property rights

Courses and course materials are copyrighted. IBT reserves the copyright. Course materials may not be distributed, published or used for public transmission without written confirmation from the IBT. Software provided in the courses may not be copied.
